PERSONNEL BOARD MINUTES  
MEETING OF NOVEMBER 30, 2015  
7:00PM

Chairman Lewis called the November 30, 2015 meeting of the Personnel Board to order at 7:00PM.

Secretary to the Personnel Board, Cathy Siciliano, called the roll. Members Chigas, Regep, Safadi and Chairman Lewis were present. Absent was Member Gholeh. There was a quorum.

Also present was Secretary to the Personnel Board, Cathy Siciliano. (Attorney Katherine Ellis arrived at 7:15pm).

Motion was made by Member Regep and seconded by Member Chigas to approve the Minutes of November 2, 2015. Roll call vote:

NAYS: None.

ABSENT: Member Gholeh.

There being four ayes, no nays and one absent, the MOTION CARRIED.

Motion was made by Member Regep seconded by Member Chigas to go to closed session regarding the review of backgrounds checks of auxiliary police officer candidates.

Roll call vote:

There being four ayes, no nays and one absent, the MOTION CARRIED.

The Board went into closed session at 7:01pm.

The Board returned to open session at 7:53pm.

Chairman Lewis stated that he "looked for a motion to approve fourteen candidates to be contacted by Secretary Siciliano to arrange interviews and prints. We'll need to talk about the dates on that in just a minute. And then look for, along with that, to be prints only for James Rathburn before we do any scheduling and then we need a work history and prints only from candidate Rafferty. So right now we are just going to approve with this motion approve our secretary to make the contacts and after that we'll firm up the dates and times that we'll be looking at those times. So, I'll look for that motion."

Motion was made by Member Chigas and seconded by Member Regep. Roll call vote:

AYES: Members Chigas, Regep, Safadi and Chairman Lewis.

NAYS: None.

ABSENT: Member Gholeh.

There being four ayes, no nays and one absent, the MOTION CARRIED.

A discussion followed regarding the dates and times for the interviews. The Personnel Board decided that the interviews would begin on Monday, December 7, 2015 at 6:00pm with eight candidates scheduled for ten-minute interviews. They would continue on Tuesday, December 8, 2015 at 6:00pm with the remaining candidates' ten-minute interviews. Chairman Lewis stated that the secretary need not be at these interviews.

There was a discussion on the 2016 regular meeting dates and times. The concurrence was that the meeting dates would be the last Monday of the month and at 7:00PM.

Motion was made by Member Regep and seconded by Member Chigas to adjourn.
