PERSONNEL BOARD MINUTES
September 24, 2018
7:00PM

Chairman Lewis called the September 24, 2018 meeting of the Personnel Board to order at 7:00pm.

There being three ayes, no nays and two absent, the MOTION CARRIED.

Chairman Lewis called for a special meeting to be held on October 15, 2018 at 7:00pm. He also asked that the applications for auxiliary police officer candidates be reviewed at that meeting.

Chairman Lewis looked for a motion to adjourn. Motion was made by Member Chigas and seconded by Member Gholeh. By voice vote, the MOTION CARRIED.
