

VILLAGE OF BRIDGEVIEW
PERSONNEL BOARD MINUTES
SPECIAL MEETING
OCTOBER 15, 2018
6:00PM

Chairman Lewis called the October 15, 2018 special meeting of the Personnel Board to order at 6:00pm.

Roll Call indicated that Members Regep, Gholeh, Mazarka and Chairman Lewis were present. Absent was Member Chigas. There was a quorum.

Also present were Attorney Katherine Ellis and secretary to the Personnel Board, Cathy Siciliano.

Chairman Lewis looked for a motion for approval of the Minutes of September 24, 2018.

Motion was made by Member Gholeh and seconded by Member Regep. Roll call vote:

AYES: Members Regep, Gholeh and Chairman Lewis.

NAYS: None.

ABSTAIN: Member Mazarka.

ABSENT: Member Chigas.

There being three ayes, one abstain, no nays and one absent, the MOTION CARRIED.

Chairman Lewis introduced the newest member to the Personnel Board, Joe Mazarka. who was replacing former Member Safadi who recently resigned.

Chairman Lewis looked for a motion to go into closed session "to discuss matters of personnel".

Motion was made by Member Gholeh and seconded by Member Regep. Roll call vote:

AYES: Members Regep, Gholeh, Mazarka and Chairman Lewis.

NAYS: None.

ABSENT: Member Chigas.

There being four ayes, no nays and one absent, the MOTION CARRIED.

The Personnel Board went into closed session at 6:07pm.

The Personnel Board returned to open session at 6:31pm.

Item number five on the October 15, 2018 agenda was tabled by Chairman Lewis as the Chairman wanted to contact Chief Mancha on this matter.

Regarding item number six on the October 15, 2018 agenda, Chairman Lewis looked for a motion to send the following auxiliary officer candidates' info for basic background checks by the Bridgeview Police Department:

Benjamin Gamino, Joseph Lamer, Cristian Lopez, Donna Stavrakis, Eduardo Tamez, Lukasz Toczek and Adrian Zaragoza. Motion was made by Member Regep and seconded by Member Gholeh. Roll call vote:

AYES: Members Regep, Gholeh, Mazarka and Chairman Lewis.

NAYS: None.

ABSENT: Member Chigas.

There being four ayes, no nays and one absent, the MOTION CARRIED.

Chairman Lewis discussed a new Firefighter list with changes to be made to the basic requirements. The Chairman stated that he will talk with the Mayor regarding this matter. Outside preparation and testing will be done. Also discussed was the timeline and requirements for making changes. Chairman Lewis stated that the Firefighters' Promotional List was posted and shows the names and scores of the "eight out of the ten" who took the test. Also discussed was that all the candidates who took the test were to meet with the Personnel Board at the next meeting. The Police promotional testing was discussed and would probably begin after the New Year.

Chairman Lewis looked for a motion to adjourn. Motion was made by Member Mazarka and seconded by Member Regep. By voice vote, the MOTION CARRIED.

The meeting adjourned at 6:58pm.
