MAYOR'S CONFERENCE AREA

Chairman Lewis called the March 25, 2019 Meeting of the Personnel Board to order at 7:00pm.

Chairman Lewis looked for a motion to send the following candidates for psychological testing: Donna Stavakis, Erick Garcia, Nick Melendez, Adrian Zaragoza, Benjamin Gamino and Cristian Lopez. Motion was made by Member Gholeh and seconded by member Mazarka. Roll call vote:

AYES: Members Mazarka, Gholeh and Chairman Lewis.

NAYS: None.

ABSENT: Members Regep and Chigas.

There being three ayes, no nays and two absent, the MOTION CARRIED.

Chairman Lewis directed the secretary to contact candidate Luis Yanez, Jr. to complete the rest of the polygraph testing. The chairman also directed the secretary "to send a letter to the candidate discussed in closed session a denial letter."

Chairman Lewis looked for a motion to approve the \$280.50 bill from the Des Plaines Valley News for an ad for the Bridgeview Fire Department entry level process and a \$298.00 bill from The Blue Line. Motion was made by Member Mazarka and seconded by Member Gholeh. Roll call vote:

AYES: Members Mazarka, Gholeh and Chairman Lewis.

NAYS: None.

ABSENT: Members Regep and Chigas.

There being three ayes, no nays and two absent, the MOTION CARRIED.

Chairman Lewis stated that if there was a need for a special meeting within the next couple of weeks, for promotional process, we could possibly have it on April 15<sup>th</sup> or April 22<sup>nd</sup>. The Chairman expressed preference for April 15<sup>th</sup>. He also stated that he would send a note out regarding this.

Chairman Lewis looked for a motion to adjourn. Motion was made by Member Gholeh and seconded by Member Mazarka. By voice vote, the MOTION CARRIED.
